# JOINT VENTURE CASE STUDY

In addition to joint ventures in both the Construction (MEP) and Healthcare (Dental) sectors, Morr & Co advised a listed client in relation to a joint venture in the aviation sector.

The joint venture related to the supply, operation and maintenance of aircraft for the purposes of personnel and equipment transportation. The agreement included put and call options over shares in the joint venture company, the exercise price for which was based on the financial performance of the operational agreement entered into by the joint venture company and the third-party customer, expected to bring in revenues well in excess of £100M.
